Things to Know

1. There must be 1 chaperone for every 10 participants in the gym at all times. Chaperones must be 18 years or older.
2. Use of the Child Watch, Fitness Center, Weight Room, Pool, and Fitness Studios are prohibited.
4. A fee will be assessed for any damaged or broken equipment.
5. **No cleats or turf shoes.**
6. Do not drag baseball bags on the floor.
7. Helmets must be worn by the hitter and person feeding the Jugs machine.
8. No baseballs on the multipurpose floor. Use dimple balls for fielding.
9. All catchers work must be done on mats provided.
10. The YMCA is not responsible for injury due to improper use of facility. Use of pitching machine is at your own risk.
13. The facility is being monitored with surveillance cameras at all times.

HOLD HARMLESS

In consideration for being allowed to participate in YMCA membership and programs, I agree to assume the risk of such activities and further hold harmless the YMCA, employees and volunteers from any and all claims, suits, losses, or related causes of action for damages, including, but not limited to, such claims that may result from my injury or death, accidental or otherwise, during or arising in any way from my YMCA involvement.
